He was born in 1970 in Ankara. He graduated from the Department of Bio-systems Engineering, Ankara University earning a bachelors degree in bio-systems engineering in 1992. He earned his M.Sc. and Ph.D. degrees from the Graduate School of Natural and Applied Sciences, Ankara University respectively, in 1994 and 1998. He studied a part of his Ph.D. at Warsaw University within NATO-Science fellowship. He has been awarded Alexander von Humboldt fellowship in 1998 and conducted post-doctoral studies in Technical University of Munich (Dept. of Biosystems Engineering) for two years. Between 2000-2002, he was nominated as the Advisor to the State Minister and regional development projects coordinator at Turkish International Cooperation Agency (TICA).

Concurrently, he was also nominated as the Resident Representative of TICA to Kazakhstan. In 2002, he was appointed as associate professor to the Department of Industrial Technology Education, Gazi University. In 2005, he was promoted to full professor and appointed to the Chair of the Department. Between 2006 and 2008, nominated as the Advisor to the Rector. He designed and structured the "IP Support Unit" in Gazi University as the unique model in Turkey. Along with this, he supervised the European project "Establishment of Technology and Transfer Offices" supported by European Patent Office (EPO) and Turkish Patent Institute (TPE) for the conversion of IP Support Unit to Technology and Transfer Office. The achievements in that field were deemed worthy for the International IP Rights Research Award in 2008. Beyond, he has officially qualified and obtained the title of "Patent Representative" in 2009.

He involved in several European pilot projects particularly in Leonardo da Vinci and Erasmus Programs as promoter, coordinator and supervisor. One of his multilateral projects within Leonardo da Vinci pilot measure "New Approaches in Technology Training" was selected in the Compendium of 50 successful projects by the European Commission (Helsinki Awards) among the projects implemented throughout Europe between 2000 and 2006 within Leonardo da Vinci pilot measure. This achievement was also deemed worthy for the service award of Gazi University. Furthermore, he was involved in ESF-COST E-34 action as the member of the management committee. He delivered lectures at University of Duisburg-Essen, University of Flensburg, University of Potsdam and University of Sevilla within Erasmus Program in different periods. Apart from these, he was selected as the Bologna Expert (2007-2008) by the Turkish Higher Education Council and European Commission and continued his studies with a main responsibility on quality assurance in higher education. In 2005, he has been selected as an Expert at European Commission for assessing the European Union LLP projects and policies and since then has been partially working in Executive Agency (EACEA), Brussels. Apart from that, performs different tasks in the evaluation commissions for University-Industry Relationship, Technology Development and R&D Programs of the Ministry of Science, Industry and Technology.
